Necessary Requirements:

- Must be willing and able to exert in excess of 100 pounds of force occasionally, and/or in excess of 50 pounds of force frequently, and/or in excess of 20 pounds of force constantly to move objects.
- Must be willing and able to understand and operate heavy power tools in a safe manner on uneven substrates.
- Must be willing and able to perform the physical demands of the position consisting of: climbing, balancing, stooping, kneeling, crouching, reaching, handling, feeling, talking, hearing, near & far acuity, depth perception, and field of vision.
- Must be willing and able to camp near the work site for up to three nights and four days.

Special Requirements: Must be willing and able to pass a background check.

Duties: The Center for Environmental Management of Military Lands (CEMML) is a unit of the College of Natural Resources at Colorado State University. The Center provides expertise in the management of natural and cultural resources on Department of Defense Lands, and assists military installations in meeting the requirements of national, state, and local environmental laws and regulations.

This position provides technical assistance to the Environmental Natural Resources Program at Pohakuloa Training Area on the Big Island of Hawaii, in the construction of large-scale fence units to protect federally threatened and endangered plant species from ungulate damage. This position will provide leadership and oversight for a daily field crew consisting of 5-8 employees. Duties include but are not limited to:

- Oversees and works with a crew of 5-8 fence technicians constructing 6 ft. high game fence (t-post and high tensile steel woven wire) for several large-scale fence units
- Determines appropriate fencing materials and procedures for construction based on the location and type of lava
- Performs the oversight and manual labor associated with the layout and vegetative clearance for fence routes during construction
- Oversees, delegates, and performs maintenance of all field gear and equipment such as: heavy gas-powered drills/breakers, generators, chainsaws, vehicles, hand tools, and yard materials and containers
- Other duties as assigned
